- **Pause on NICE's cost recovery plans**

Plans for NICE to recover the costs of its appraisals of drugs, medical devices and diagnostics, through charges to the companies which make them, have been put on hold until the Government completes its life sciences strategy.

- **NICE approves kidney cancer drug for NHS use**

Patients with advanced kidney cancer will have routine NHS access to the drug everolimus following recommendations by NICE, rather than apply to the Cancer Drugs Fund (CDF).

- **Everyone with learning disabilities should have their mental health checked annually, NICE says, as fears thousands may be undiagnosed**

Experts acknowledge that mental health problems may be more difficult to diagnose for people with learning disabilities. This is because it can be harder for the person to explain how they are feeling and what help they would like

- **Kadcyla too expensive for routine funding on NHS**

Kadcyla (also called trastuzumab emtansine and made by Roche) is currently being funded through the Cancer Drugs Fund. NICE is looking again at its 2015 guidance on the drug to see whether it should be funded routinely on the NHS.

- **New NICE guideline to help people take control of their asthma could save the NHS millions**

NICE has issued draft guidance setting out what medicines adults, young people and children with asthma should take to control symptoms and reduce asthma attacks.

- **NICE focuses on improving treatment and diagnosis of liver disease**

People who drink too much should be sent for scans to detect early liver disease, says NICE

- **Councils should provide oral health programmes in schools, says NICE**

Social care providers should also ensure oral health is included in care plans for people receiving support, says NICE
